Exportable Information into the FCI System

DCFS information is available for all children for whom reports of child abuse or neglect have been received and for whom an investigation has been completed. An exception is in cases where the investigation concluded that the allegations were unfounded. Incident information will be provided at the time of the Emergency Response referral closure.

The following list provides information detailing what each agency is required to export into the system. The DA will export information to FCI relative to the following circumstances when the following violations of the PC are alleged in the complaint:

- The Department of Public Health (DPH) will export information to FCI regarding:
 - o Children born to mothers 14 years of age or younger
 - Children under 12 years old with sexually transmitted diseases
- The Department of Mental Health (DMH) will export information to FCI for children who are:
 - Suspected to be at-risk for abuse/neglect and a concomitant report has been filed with DCFS.
 - Referred for mental health services by DCFS with abuse/neglect already substantiated.
- The Probation Department (Juvenile Probation) data will be exported to FCI under the following circumstances:
 - Those referred under the age of 14
 - Those with a sustained charge of "rape of minor under 14"
 - o Those with a sustained charge of drug possession, use, or sales
 - Those with a sustained charge as listed by the District Attorney in this document

- Those with a sustained firearm possession charge
- Data for Adult Probationers with family members that are children will be exported to FCI under the following circumstances:
 - Probationers convicted of offenses requiring registration under Section 290 of the Penal Code (PC).
 - o Probationers convicted of 273.5 PC (corporal injury).
 - Probationers supervised on Family Violence caseloads.
 - Female probationers supervised on Narcotic Testing caseloads.
- Department of Public Social Services (DPSS) will export information to FCI relating to:
 - Pregnant youth 12 years and under
 - o Minor mothers under 14 years old
 - Los Angeles Sherriff's Department (LASD) will export information to FCI if a child or a child's sibling has been named in a suspected child abuse report.
