

Road to Federal Eligibility Re-determination

DCFS Policy: WIC 388 Petitions: Response Reports (0300-503.41)

Obtain Consent from 18-Year-Old Youth

On, or immediately after the youth's 18th birthday, CSW talks to the youth (via in-person contact, phone, email or text message) and requests their consent to terminate and then immediately re-establish court jurisdiction. CSW enters a contact in CWS/CMS about the discussion and outcome.

Complete & Sign SOC 163 Voluntary Re-entry Agreement for Foster Care Form

If youth consents, request their signature on the SOC 163 Voluntary Re-entry Agreement for Extended Foster Care

YOUTH DECLINED CONSENT?

If youth does **NOT** consent, consult with County Counsel

NON-CONSENTING YOUTH THIS WAY

Complete Notice of Request & Proofs of Service

In SNAP 2.0, CSW completes the NOTICE OF REQUEST. CSW selects, "Tomorrow's Date" as the hearing date in SNAP 2.0

JV-Forms, Notices and Beyond

Complete JV-469 & JV-471 Forms

CSW completes JV-469 form (including date & method of youth's consent was obtained) and case identifying information at the top of JV-471 form and select checkbox #2

Submit SOC 163, JV-469, JV-471 form, Notice of Request & Proofs of Service to court

CSW uploads signed SOC 163 and completed JV-469, JV-471 & Notice of Request to Court Liaison Walk-on System

Court grants the WIC 388(f) Petition Request

Court may grant the petition WITHOUT a hearing. If someone objects to the petition, court may set a hearing date.

- SOC 162
- SOC 163
- FC 2 NM
- SOC 158A
- SAWS 1
- Signed JV-471 form (or minute order) granting WIC 388(f) petition

Submit FCSS 280 Evaluation for Federal Funding Eligibility Due to Re-entry

Within 10 days after the court grants the WIC 388(f) petition (or court hearing) CSW submits an automated FCSS 280 request for an evaluation for federal funding eligibility due to re-entry

FC 2 NM

Complete & Sign New SOC 162 & FC 2 NM forms

Once petition is granted by court, CSW completes new SOC 162 and FC 2 NM forms. CSW and NMD sign BOTH forms.
